Primorac (1998) calls rape one of the primary aspects where feminist philosophical, social, and legal thought has been especially influential.

Radical feminism is a concept that places a strong emphasis on the patriarchal causes of gender inequality, or more precisely, the social dominance of women by males. Radical feminism believes that patriarchy oppresses women and favours men by dividing societal rights, advantages, and power primarily along sex lines (Lewis, 2020).

Radical feminism is opposed to current social and political structures in general because they are intrinsically based on patriarchy. Radical feminists, therefore, frequently view political activity inside the current system with skepticism and instead priorities cultural shifts that challenge patriarchy and related hierarchical institutions (Lewis, 2020).

The desire for empowerment and radical feminism is the theme of this novel is, resulted from the severe tragic situation faced by Taylia, who's throughout struggle creates an open element of feminism rather than radical feminism as well in this novel which will be analyzed with a feminist lens.

In this research, the war of sexes and enmity is intended to find out about the status of women in *Like a Bird* (2020).

According to Mackay (2021), one of the major tenets of radical feminism has always been the denial of biological essentialism, or the idea that sex roles are innately biological. Shulamith Firestone, the author of "The Dialectic of Sex", asserted that the ultimate aim of the feminist revolution must be "not just the eradication of male privilege but of the sex differentiation itself: genital variations between human beings would

no longer matter in terms of culture." Whatever the "actual" distinctions between the sexes may be, we are not likely to know them unless the sexes are treated differently, that is alike, as the radical feminist, poet, and artist Kate Millett stated in her seminal 1970 text Sexual Politics. And right now, that is pretty distant from the truth.

# Research Methodology

The present study is qualitative and is intended to analyze the text of *Like a Bird* (2020) under the theoretical framework of Ti, Grace Atkinson's theory of Radical feminism (1970).

Fundamentally, "radical feminism originated with the notion that the sexes are inherently antagonistic, that males have power over women, and that the only way to understand society and its different social interactions is in reference to that condition" (Hunter, 2004). Here, men control society's resources and use them to maintain women's subordination within the greater social structure. To put it another way, "radical feminists tend to understand the power in terms of dyadic relations dominance/subordination, generally of understood on analogy with the relationship between master and slave" (Allen, 2011). It is a harsh view of how men and women interact in terms of power, where males exploit their position of authority to severely limit the role of women.

Radical feminism has a lot in common with Marxism in its belief that there is a constant battle

for dominance between the sexes. There is the oppressor, who in this case is a male, and the oppressed, who is a female and is subjected to the oppressor's stern. Both theories essentially address ideas of power relations and "give descriptions of how social systems with systematic inequity might be internally reasonable yet unfair" (MacKinnon, 1982). Marxist principles have been incorporated into radical feminism, which has replaced class distinctions with gender ones. Radical feminism, like Marxist theory, describes this continual struggle as a means of igniting a revolution against the oppressors. Contrary to a Marxist revolution, a feminist one can occur within a capitalist system and doesn't necessitate a total restructuring of the economy. Instead, it necessitates the overhaul of cultural and social structures in order to put a stop to patriarchal control and restore the equality of the sexes.

Ti, Grace Atkinson's theory of Radical feminism (1970) the main points of this theory are as follows:

- **1.** The women's movement is at war, but who is the enemy? If it is society or man.
- **2.** Women should understand the battle strategy of men that have kept them so successfully pinned down.
- 3. Radical feminism believes that women as a group /class somehow fit into a political analysis of society.
- 4. Women have been measured as human beings throughout history. They should take the position first by engaging in the battle and later on being themselves into the position of dialogue.
- 5. Women should define what a woman is and what a woman is as a class.
- **6.** Both women and females are terms that favor men.
- **7.** Women are a political class characterized by a sexual function.
- **8.** Women must be given some individual autonomy.
